### BOARD OF FINANCE RESOLUTION CONCERNING TAX RATES FOR FISCAL YEAR 2011-2012

MAY 18, 2011

**WHEREAS**, Section 8-30-10 of the *City of Stamford Charter* states that on or before the twenty-fifth day of May, the Board of Finance shall determine and fix the tax rates and service charges upon the ratable estate in each of the tax districts of the City; and

**WHEREAS**, Section 8-40-10 of the *City of Stamford Charter* states that all motor vehicles within the City shall be taxed at a uniform city-wide mill rate;

**THEREFORE BE IT RESOLVED BY THE CITY OF STAMFORD BOARD OF FINANCE**, that the tax rates set forth herein were read into the official record by the Board of Finance at its May 17, 2011 as:

<i>Tax District "A":</i>	<b>17.49 mills</b>
<i>Tax District "B":</i>	<b>17.10 mills</b>
<i>Tax District "C":</i>	<b>16.31 mills</b>
<i>Tax District "C/S":</i>	<b>16.64 mills</b>
<i>Motor Vehicles:</i>	<b>26.50 mills</b>
<i>Personal Property District:</i>	<b>17.49 mills</b>
